**INTRODUCTION**

Reference is made to the announcement of the Company dated 20 December 2019. The purpose of this circular is to provide you with information in respect of the special resolution to be proposed at the EGM to seek the approval of the Shareholders in respect of the proposed Change of Company Name.

## LETTER FROM THE BOARD

### PROPOSED CHANGE OF COMPANY NAME

The Board proposes to change the Company's English name from "Yat Sing Holdings Limited" to "China Supply Chain Holdings Limited" and its dual foreign name in Chinese from "日成控股有限公司" to "中國供應鏈產業集團有限公司", subject to the conditions set out in the paragraph headed "Conditions of the Change of Company Name" below.

### CONDITIONS OF THE CHANGE OF COMPANY NAME

The Change of Company Name is subject to the fulfillment of the following conditions:

- (a) the passing of a special resolution by the Shareholders approving the Change of Company Name at the EGM; and
- (b) the approval of the Registrar of Companies in the Cayman Islands being obtained for the Change of Company Name.

Subject to the satisfaction of the conditions set out above, the Change of Company Name will take effect upon the date on which the Registrar of Companies in the Cayman Islands enters the new English name and the new dual foreign name in Chinese of the Company on the register of companies in place of the former English name and the former dual foreign name in Chinese and issues a certificate of incorporation on change of name. The Company will then comply with the necessary registration and/or filing procedures with the Companies Registry in Hong Kong.

### REASONS FOR THE CHANGE OF COMPANY NAME

The Change of Company Name is to reflect the intention of stepping into supply chain services and supply chain financial services of the Company. The Board considers that the Change of Company Name will provide the Company with a fresh new corporate image and identity. The Board is of the opinion that the Change of Company Name will benefit the Company and is in the best interests of the Company and the Shareholders as a whole.

### EFFECTS OF THE CHANGE OF COMPANY NAME

The Change of Company Name will not affect any rights of the Shareholders or the Company's daily business operation or financial position. All existing share certificates of the Company in issue bearing the existing name of the Company will, upon the Change of Company Name becoming effective, continue to be evidence of title to the Shares and will be valid for trading, settlement, registration and delivery purposes.

Accordingly, there will not be any arrangement for free exchange of the existing share certificates of the Company for new certificates bearing the new name of the Company. Upon the Change of Company Name becoming effective, any issue of share certificates will bear the new name of the Company and the securities of the Company will be traded on the Stock Exchange under the new name. In addition, after the Change of Company Name becomes effective, the Company will change the English and Chinese stock short names accordingly, subject to the confirmation of the Stock Exchange.

### EGM

Whether or not you intend to attend the EGM or any adjournment thereof, you are requested to complete and return the enclosed proxy form in accordance with the instructions printed thereon to the branch share registrar and transfer office of the Company in Hong Kong, Union Registrars Limited at Suites 3301–04, 33/F., Two Chinachem Exchange Square, 338 King's Road, North Point, Hong Kong as soon as possible but in any event not less than 48 hours before the time appointed for holding the EGM or at any adjournment thereof (as the case may be). Completion and return of the proxy form will not preclude you from attending and voting in person at the EGM or at any adjournment thereof (as the case may be) if you so wish, and in such event, the instrument appointing the proxy shall be deemed to be revoked.

To the best of the Directors' knowledge, information and belief, having made all reasonable enquiries, none of the Shareholders is required to abstain from voting on the special resolution to be proposed at the EGM.

### VOTING BY POLL

Under Rule 13.39(4) of the Listing Rules, any vote of shareholders at a general meeting must be taken by poll. Accordingly, the special resolution proposed at the EGM to approve the Change of Company Name will also be taken by poll. A poll results announcement will be made by the Company after the EGM in accordance with Rule 13.39(5) of the Listing Rules.

### RECOMMENDATION

The Board believes that the Change of Company Name is in the best interests of the Company and the Shareholders as a whole and therefore recommends the Shareholders to vote in favour of the resolution as set out in the notice of EGM.
