### **CHANGE OF COMPANY NAME, STOCK SHORT NAMES AND COMPANY WEBSITE ADDRESS; AND THE ADOPTION OF COMPANY LOGO**

Reference is made to (i) the announcement of Solomon Worldwide Holdings Limited (formerly known as Jete Power Holdings Limited) (the “**Company**”) dated 20 October 2021; (ii) the circular of the Company dated 27 October 2021 (the “**Circular**”); and (iii) the announcement of poll results of the extraordinary general meeting (the “**EGM**”) of the Company dated 12 November 2021 in relation to, amongst other things, the Change of Company Name. Unless the context otherwise requires, capitalised terms used in this announcement shall have the same meanings as those defined in the Circular.

#### **CHANGE OF COMPANY NAME**

The Board is pleased to announce that subsequent to the passing of a special resolution by the Shareholders at the EGM held on 12 November 2021 approving the Change of Company Name, the Registrar of Companies in Cayman Islands has issued the certificate of incorporation on change of name of the Company on 18 November 2021. Accordingly, the English name of the Company has been changed from “Jete Power Holdings Limited” to “Solomon Worldwide Holdings Limited” and the dual foreign name in Chinese of the Company has been adopted and registered as “所羅門環球控股有限公司” in place of its former Chinese name of “鑄能控股有限公司” which had been used for identification purposes only, both with effect on 18 November 2021. The certificate of registration of alternation of name of registered non-Hong Kong company was issued by the Registrar of Companies in Hong Kong on 9 December 2021 confirming the registration of “Solomon Worldwide Holdings Limited 所羅門環球控股有限公司” as the new name of the Company in Hong Kong under Part 16 of the Companies Ordinance (Chapter 622 of the Laws of Hong Kong).

## **EFFECT OF THE CHANGE OF COMPANY NAME**

The Change of Company Name will not affect any rights of the holders of securities of the Company or the Company's daily business operation and its financial position. All existing share certificates in blue colour in issue bearing the old name of the Company shall, after the Change of Company Name becoming effective, continue to be evidence of title to such Shares and the then existing share certificates in purple colour bearing the old name of the Company will continue to be valid for trading, settlement, registration and delivery purposes. In light of the Share Consolidation, which has become effective on 17 November 2021, the Company has arranged free exchange of share certificates of the existing Shares for the new share certificates of Consolidated Shares from 17 November 2021 to 24 December 2021 (both days inclusive). With the change of name of the Company becoming effective, new share certificate(s) in purple colour bearing the new name of the Company will be issued with effect from 20 December 2021 instead of the old share certificate(s) in blue colour bearing the old name of the Company (or such certificates in purple colour bearing the old name of the Company for the Consolidated Shares). There will not be any arrangement for free exchange of the existing share certificates for new share certificates bearing the new name of the Company. Any new share certificates will be issued only in the new name of the Company with effect from 20 December 2021.

## **CHANGE OF STOCK SHORT NAME AND PARALLEL TRADING ARRANGEMENT**

From 1 December 2021 up until 21 December 2021, there are parallel trading of Shares regarding the Share Consolidation. With effect from 20 December 2021 and up until 21 December 2021, the parallel trading of Shares is under both (i) original counter under the stock short name of "SOLOMON WW-NEW" (in English) and "所羅門環球(新)" (in Chinese), in the form of new share certificate(s) in purple colour bearing the new name of the Company and existing share certificate(s) in purple colour bearing the old name of the Company both issued for the Share(s); and (ii) temporary counter under stock short name of "SOLOMON WW-OLD" (in English) and "所羅門環球(舊)" (in Chinese) in the form of existing share certificates in both blue and purple colours bearing the old name of the Company issued for the Share(s).

With effect from 22 December 2021, the Shares will only be traded under the original counter under the new stock short name of "SOLOMON WW HLDG" (in English) and "所羅門環球控股" (in Chinese) in the form of new share certificate(s) bearing the new name of the Company and existing share certificate(s) bearing the old name of the Company both in purple colour.

## **CHANGE OF COMPANY WEBSITE ADDRESS AND THE ADOPTION OF COMPANY LOGO**

To reflect the Change of Company Name, the logo of the Company will be incorporated as “**Solomon**” and the website of the Company will be changed from “<http://www.jetepower.com>” to “<http://www.solomon-worldwide.com>” with effective from 20 December 2021.
